#### V. New business


- a) Principle Report

- (1) Staff burnout. Original Covid plan was denied. Do not want to give up on sustainable ways for teachers/staff and students.
- (2) Proposed Wednesdays be a prep/blended day for staff and the department of education denied it. I would like to propose that on the days the CTFN have their closure days (every second Friday), the students do a family based activities at home and the teachers get a breather prep day for blended learning. The teachers work on the Google classrooms and have distance learning ready to go if and when needed.
- (3) Unrealistic expectations of what students should be doing or not doing during a pandemic.
- b) Parent/Caregiver concerns re: drug use
  - Kids are eating edibles during school hours. Some kids are taking off during lunch and smoking weed. Kids are getting other kids to hold their drugs and paraphernalia.
  - ii) School Council agrees that students are no longer allowed to leave school property during school hours unless escorted by a parent. Sheena will draft the letter and Melisa will sign it as the Chair.
- c) Winter Clothes for students
  - Students are coming to school without proper snow gear. CTFN registered students get \$350 funding for winter clothes but there are students who do not qualify. Heike suggests maybe we do a fundraiser, but kids may still not wear it. Melisa and Sheena will draft a letter to CTFN and see if they are interested in purchasing hat and mitts for every student.
- d) Covid; what will the school do?
  - i) Staff discuss areas to monitor and improve, refreshed expectations of the safe six with students, supply different soap than what PMD supplies, mask and face shields are used during close proximity, cleaning cloths and masks get washed daily, day custodian has the contract to the end of the school year.
  - ii) School Council agrees that the school should shut down if CTFN shuts down. Sheena will draft a letter to YG and Melisa will sign it as chair. Cynthia will send contact info to Sheena.
